

REGULATION

on tuition discounts granted to certain categories of foreign citizens and stateless persons who enter MIPT under the contracts for the paid educational services at the expense of individuals and (or) legal entities

I. General provisions

1. This Regulation was developed in accordance with the Federal Law of December 29th, 2012 No. 273-FZ “On Education in the Russian Federation”, Article 54, Part 5 as well as local regulations of the MIPT, in order to implement the decree of the President of the Russian Federation dated May 7, 2018 No. 204 “On the national goals and strategic objectives of the development of the Russian Federation for the period up to 2024”.

2. This Regulation determines the grounds, conditions and procedure for reducing the cost of paid educational services established in accordance with the Order on the cost of education for the relevant period of study (hereinafter referred to as discounts) for foreign citizens and stateless persons (hereinafter jointly – foreign citizens), applicants and students of MIPT on educational programs of higher education under the contract on the provision of paid educational services (hereinafter referred to as the Contract) at the expense of individuals and (or) legal entities.

3. This Regulation was developed with the aim of attracting talented foreign citizens to study the basic educational programs of higher education – undergraduate, graduate and post-graduate programs, and also to enhance the motivation of foreign students to achieve high educational results when studying at MIPT.

4. In accordance with the current legislation, MIPT is entitled to reduce the cost of paid educational services under the Contract, taking into account the coverage of the missing cost of paid educational services at its own expense, including funds received from income-generating activities, voluntary donations and earmarked contributions from individuals and/or legal entities.

II. Types of discounts and procedure of its granting

5. MIPT sets the following types of discounts for foreign citizens on tuition fees for higher educational programs under the Contract:

- 5.1. applicants who received 85% (eighty-five percent) of the maximum points and higher;
- 5.2. graduates of preparatory course, undergraduate and graduate studies of MIPT;
- 5.3. students of partner universities when transferring or entering the next level of education at MIPT;
- 5.4. winners and awardees of the olympiads, specified in Supplement 1 for these Regulations;
- 5.5. participants of short-term internships, summer and winter MIPT schools;
- 5.6. students who have high academic achievement.

6.1. A foreign citizen applying for a discount provides an application:

- 6.1.1. According to the clauses 5.1–5.5 and the form provided in the Supplement 3– to the admission office;
- 6.1.2. According to the clause 5.6 and the form provided in the Supplement 3 – to Phystech Schools offices.

6.2. The issue of granting discounts to a foreign citizen and its amount is considered by the relevant commission:

- 6.2.1. for clauses 5.1–5.5 – admission commission;
- 6.2.2. for clauses 5.6 – commission for the transferring students from paid tuition to free.

6.3. Within five days from the date of the student's application receipt Phystech School endorses the application and sends the application to the commission for the transferring students from paid to free tuition, and also:

- information on the results of interim attestation, the state final attestation of a student for two semesters preceding his application for a discount (in the form of a record from test and examination lists);
- petition for a discount in the form given in Supplement 4.

7. In case of the decision on granting a discount to a foreign citizen, a corresponding supplementary agreement to the Contract is concluded with the student:

- 7.1. for clauses 5.1-5.5 – by admission office;
- 7.2. for clause 5.6 – by educational office.

8. A discount may be set only for one of the grounds specified in clause 5 of the Regulations. If a foreign citizen has the right for discounts for several reasons, the discounts are not cumulative, and the student is given the biggest discount.

9. When transferring a foreign citizen from one educational unit to another, and (or) from one educational program to another, the previously set discount remains in full.

10. If a foreign citizen who has a discount is granted academic leave, maternity leave or parental leave until the child reaches the age of three (hereinafter referred to as leave), then the specified discount is reserved for him after his leave from leave until the end of the Contract validity.

III. The amount of tuition discounts for foreign applicants and students of educational programs of higher education at MIPT

11. Foreign citizens who enter MIPT under the contracts for the paid educational services are given discounts in the following amount:

11.1. The discount for foreign citizens according to the results of entrance examinations (clause 5.1 of this Regulation) for applicants who earned 85% (eighty-five percent) of the maximum possible value of the sum of all points for the entrance tests is 15% (fifteen percent) of the set tuition fee;

11.2. The discount for foreign citizens who graduated from the preparatory course, undergraduate or graduate programs of MIPT (clause 5.2 of this Regulation), is provided in the amount of 20% (twenty percent) of the set tuition fee;

11.3. The discount for foreign citizens who graduated from higher education institutions-partners of MIPT, with whom educational cooperation agreements were concluded, as well as foreign citizens from partner universities studying at MIPT for international joint programs and international academic mobility programs (clause 5.3 of this Regulation), provided in the amount of 20% (twenty percent) of the set tuition fee;

11.4. The discount for foreign citizens who are winners and awardees of olympiads (clause 5.4 of these Regulations) is granted in the amount of 100% (one hundred percent) for the competitions indicated in clauses 1-10 of Supplement 1; 50% (fifty percent) for the winners, 20% (twenty percent) for the winners and 10% for the awardees and the winners of any of the qualifying stages of the Olympiad specified in clause 11 of Supplement 1; 25% (twenty-five percent) for the winners and 15% (fifteen percent) for the awardees of the competitions indicated in paragraphs 12-21 of Supplement 1;

11.5. Discount for foreign citizens who were participants in short-term internships, summer and winter schools organized by MIPT (clause 5.5 of this Regulation) is provided in the amount of 10% (ten percent) of the set tuition fee;

11.6. Discount to undergraduate, graduate and postgraduate students for high academic achievement (clause 5.6 of this Regulation) is granted according to intermediate certification, passing state exams in accordance with the curriculum of the last two semesters preceding the application for a discount. The discount is 20% (twenty percent) of the set tuition fee. Foreign citizens applying for a discount for high academic achievement must meet the following criteria:

11.6.1. according to the results of passing intermediate assessments, passing state exams in accordance with the curriculum of the last two semesters, not to have academic debts, including those that have been liquidated, according to the results of differentiated tests and examinations, to have marks from 7 (seven) points and higher on a 10-point (ten-point) scale;

11.6.2. not to have disciplinary penalties.

11.7. The discount is maintained until the expiration of the Contract, except for the cases specified in clause 13.

IV. Financial support for discounts granted to foreign applicants and students of educational programs of higher education at MIPT

12. The discounts mentioned in clauses 5.1-5.6 are provided at the expense of the extra-budgetary activities of MIPT.

V. Grounds for depriving a foreign citizen from the right to have a discount

13. A foreign citizen is deprived from the right to have a discount of any kind during its validity period in the event:

- application of disciplinary penalties (remark, reprimand);
- having more than two academic debts.

14. Deprivation from the right to a discount of any kind (clause 13 of this Regulation) shall be drawn up in a supplementary agreement to the Contract.

15. In the case of a foreign citizen expulsion from MIPT until the completion of the educational program and its subsequent recovery and admission to MIPT, the previously set discount is not retained.

VI. Final provisions

16. With the commencement of this Regulation, the previously set discounts do not change and are valid until the end of the period for which they were granted.

17. If any changes are made to this Regulation, the previously set discounts do not change and are valid until the end of the period for which they were granted.

18. These Regulations shall apply from the date of enactment by order of the Rector.
